## CALL FOR ABSTRACTS

Researchers, educators, government officials, consultants, managers, community leaders and others with expertise in contaminated sites are invited to submit abstracts for oral or poster presentation. Abstracts with max. 1 500 characters must be submitted electronically by online registration form by **20 MARCH 2020**:

The Scientific Committee will evaluate the submitted abstracts and select it for oral or poster presentations by **31 MARCH 2020**. Collection of papers will be available at the conference.

## NO CONFERENCE FEES

The conference is **GRATIS** for properly and timely registered participants – there are fully covered conference expenses such as accommodation for 2 nights, scientific programme, conference proceedings, all meals and a trip during the conference within its programme.

## CONFERENCE VENUE
